# What is Global Ethics Day?

Established by Carnegie Council in 2014, Global Ethics Day is an annual moment for individuals and organizations to explore the values and principles behind ethical decision-making.

It is held on the third Wednesday of every October. Since its inception, citizens, businesses, professional organizations, schools, governments, and nonprofits from over 100 countries have planned activations to empower ethics.

Update your organization's Code of Ethics




**Organize** an environmental clean-up in your community

## Australia

For multiple years, **The Ethics <u>Centre</u>** in Australia has taken part in Global Ethics Day by developing resources and hosting events exploring the role of ethics in our personal and professional lives.

## Europe

In an effort led by the European Central Bank, **Global Ethics Day** was celebrated by banks across **Europe** including the Central Bank of Ireland, the Bank of Italy, and the Bank of Spain.

## Asia

Participating in Global Ethics Day for the first time in 2024, The Geostrata, a youth-led think tank based in India, hosted a virtual panel discussion on youth engagement and the future of democracy.

## South America

The Associação Brasileira dos Profissionais de Sustentabilidade (ABRAPS) collaborated with **FECAP**, an academic institution based in Brazil, to host an eighthour virtual webinar featuring renowned experts and professionals discussing ways to advance ethics and sustainability.

## Africa

Students at Baze University's Ethics Law Clinic in Nigeria filmed short form videos on social media sharing what ethics means to them.

## Global

The Association of Chartered Certified Accounts (ACCA) has been a consistent supporter of Global Ethics Day since 2017. In 2024, they published a **report** about a rise in ethical dilemmas in the accounting industry and a video about ethical leadership that has garnered over 800K views since it was published.

#### When is Global Ethics Day?

Global Ethics Day is held the third Wednesday of every October. In 2025, it will be held on October 15.

#### Who can participate?

Any individual or organization can take part in Global Ethics Day. Since 2014, we've had participants from schools, nonprofits, and businesses around the world.

#### How can individuals and organizations get involved?

Whether it's planning an event, publishing content online, or hosting a discussion with friends and colleagues, there are countless ways to explore the role of ethics in your professional or personal life.

#### Do I need to register?
